



## 4' Stick Vent and 20' Roll Vent Limited Warranty

---

### What is Warranted and for How Long

Guardian Building Products Distribution, Inc. ("Guardian"), subject to the terms and conditions below, warrants that each of its GuardVent and GuardVent Ridge Roll products ("each a Product") is manufactured in all material respects to Guardian's product specifications and is free from manufacturing defects that could result in a loss of attic ventilation, weather infiltration and displacement under normal weather conditions and meets the acceptance criteria for attic vents (ICC AC 132, Report Number ESR-2587) for the period of the length of the warranty covering the new shingles to which the Product is attached, up to a maximum of forty (40) years from the date of original proper installation of the Product. Liability under this warranty is limited, at Guardian's exclusive option, to Guardian replacing defective Product without charge or, in the alternative, a refund of the original purchase price for such defective Product. In those instances in which Guardian determines that only a portion of the Product manifests a defect, Guardian reserves the right to limit any replacement or refund to the portion of the Product that manifests the defect.

Labor charges or other costs incurred with removal or installation of either the original or replacement Product are not covered by this warranty. In the event of replacement under the terms of this warranty, the original warranty shall apply to the replacement Product and will extend for the balance of the warranty period remaining at the time of replacement. Any Product considered to be defective should not be installed.

### Who is Covered

This warranty is granted solely to the original consumer purchaser or owner. It may not be transferred; provided that if you purchase a new residence or commercial building and are the first person to occupy the building, Guardian will consider you to be the original purchaser if the Products were installed as part of the construction of that structure.

### How to make a claim

In the event you believe that Product fails to conform to this warranty, you must notify Guardian at 1-800-231-6200, promptly followed in writing at:

Such notice must be made within thirty (30) days of the date the claimed defect was first discovered or reasonably could have been discovered. Written notice must include description of the alleged defect, a picture of the defective Product, as well as proof of the date of purchase. Guardian may then promptly inspect the Product. If such examination does disclose a defect covered by this warranty, Guardian will perform its obligations under this warranty to the extent of the Product that actually manifests defects. Guardian reserves the right to inspect any Product that is alleged to be defective prior to its removal from the installation location. Guardian will not be liable for any actions or expenditures incurred prior to written acknowledgement of Guardian responsibility under this warranty.

### Limitations

This warranty is void and does not apply to damage arising under any of the following conditions:

1. Improper installation, improper construction practices or design not in accordance with the applicable building code or any change from construction plans or specifications properly approved for the structure. Installation instructions and the applicable Product specifications are available at [www.guardianbp.com](http://www.guardianbp.com).
2. The negligence, gross negligence or willful or intentional misconduct of any third party.
3. Defects in the structure or component of the structure in which the Product is installed, or premature deterioration of the shingles or the building materials to which the Product is attached, or which are attached to the Product, including, but not limited to, movement or settling of walls or foundation of the building.
4. The Product fails, is rendered defective, or is damaged as a result of materials installed or stored near the Product.
5. The Product is damaged or a failure is caused by modifications not executed by Guardian, impact from foreign objects, hail, lightning, hurricane, tornado, earthquake, flood or other acts of God, or by fire, explosion or other casualty.
6. Exposure to harmful materials or chemicals directly applied to the roof or present in the atmosphere.
7. The Product is deliberately damaged or damaged by abuse, vandalism or improper use.
8. Any other cause not involving manufacturing defects in the Product.

Purchasers of the Products are solely responsible for determining the effectiveness, suitability and safety of any particular use or application of the Product. Building code regulations vary from area to area. Purchasers should consult local building and safety codes for specific requirements.

Guardian reserves the right to discontinue or modify any of its Products without notice to the purchaser and shall not be liable as a result of discontinuance or modification. If Guardian replaces any Product under this warranty, it may substitute Product designated by Guardian to be of comparable quality in the event the Product initially installed has been discontinued or modified.

No variation or change in this warranty will be binding upon Guardian unless made in writing and signed by an officer of Guardian.

This warranty gives you specific legal rights and remedies, and you may also have other rights which vary from state to state.

This warranty shall only be applicable and enforceable in the United States of America.
